Please use cart path when possible and without exception on par 3 holes.

On hole No. 5, safety fences on fairway are immovable obstructions. Take relief under no penalty.

On hole No. 17, take mandatory relief (no penalty) from rock wall surroundings. At trees adjacent to No. 17 green, proceed to designated drop area under no penalty.

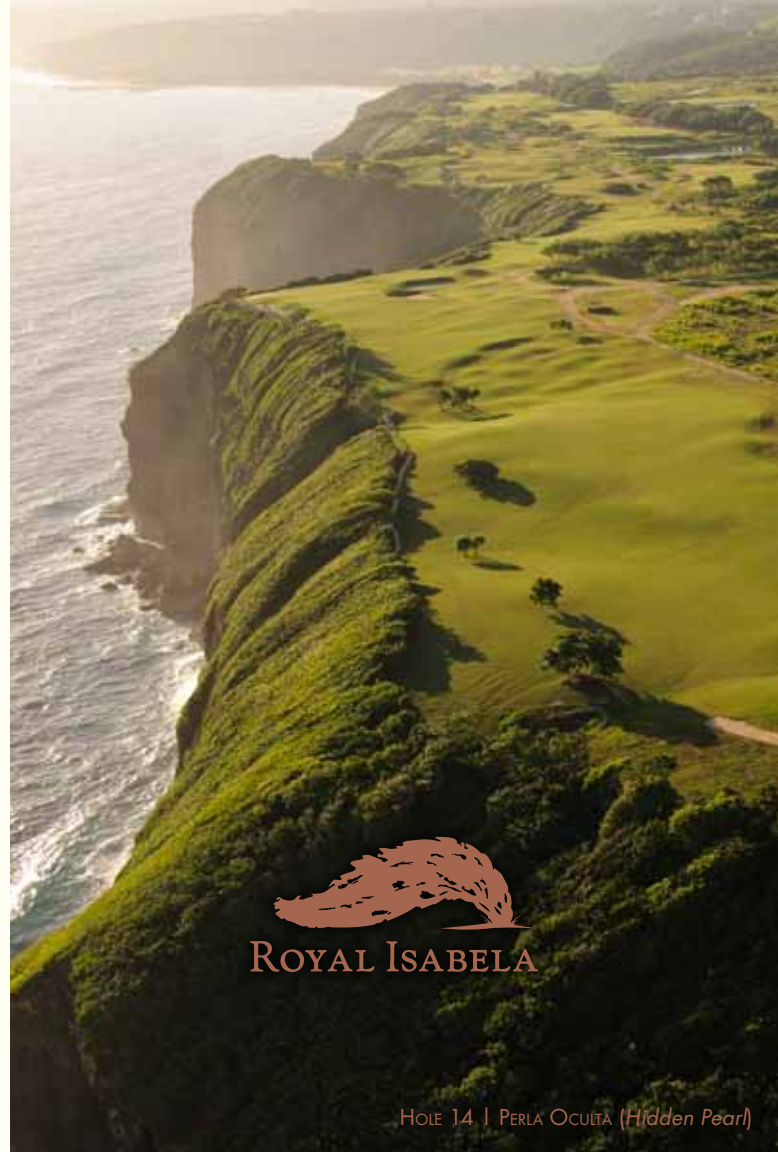
In all areas not marked as hazards or out of bounds, the ball shall be played as it lies.
